SVA WELLBEING SYSTEM – PROGRAM POLICY

ONGOING ACCESS TO THE CONTENT HUB

The client will have access to the content of the program within the Content Hub for as long as the program is in existence, this includes any updates or add-ons.

ACCESS TO THE PROGRAM SPECIFIC FACEBOOK GROUP FOR DURATION OF PROGRAM ONLY

The client will have access to the private Facebook group that is part of the program for 13 weeks from the time of your enrollment. At the end of 13 weeks, you are invited to join the free community Facebook Group or an alumni group. You will be removed from the Sva Wellbeing System facebook group.

SIGN-IN NAME, PASSWORD, UNIQUE IDENTIFIERS

During the registration process for Registered Users, we will ask you to create an account, which includes a sign-in name ("Sign-In Name"), a password ("Password"), and perhaps certain additional information that will assist in authenticating your identity when you log-in in the future ("Unique Identifiers").
